

Now in our fourth year, both ARC Federal Credit Union branches have collected Stockings for the Troops donations in the month of November. This project, organized by Military Families Ministry, USA, sends care packages and cards in Christmas stockings to service members stationed abroad during the holidays. Items collected include snacks like granola bars, beef jerky, and gum. Non-food items like toothbrushes, chapstick, and card games are also collected. These care packages with stockings and their accompanying Christmas cards are especially meaningful to our troops around the holidays, when many of them may be missing home more than usual.

Military Families Ministries also partners with a local agency to provide backpacks for homeless veterans filled with water bottles, snacks, microwaveable meals, and personal care items. These backpacks are provided while the local agency provides hotel rooms for the vets and connects them to resources to get them back on their feet.

2022 IRA Contributions minimums, maximums and deadlines, oh my!

ARC members who currently have a Traditional IRA with us, please be aware of the following update for tax year 2023:

The limit on annual contributions to an IRA will increase to \$6,500. The IRA catch up contribution limit for individuals age 50 and over is not subject to an annual cost of living adjustment and remains \$1,000. Please refer to your tax advisor with any questions on how much you can contribute.

Much Ado About Taxes

AND HERE'S WHY:

Benjamin Franklin once said that nothing in this world is certain except death and taxes. If that doesn't give you a hint as to the absolute inevitability and permanence of this institution, I don't know what will. Many filers will receive an income tax refund, meaning you get back part of the money you paid in taxes throughout the year. There are a few things you should know to avoid delays if you are having your income tax refund deposited or direct deposited to your ARC account:

• If you filed a joint return, please make sure all tax filers are listed on your ARC FCU account.

Call the Credit Union to verify that you have the correct routing and account information for your deposit

• If you are trying to have someone else's income tax return deposited into your personal account, their return will be rejected. Any deposit going into an ARC FCU account much match the name(s) on the account.
